
# **Executive Summary**

Over the past 24 hours, the Ohio Department of Health reported 1,290 (70,601) total new cases, 115 (9,324) hospitalizations, 21 (2,280) ICU Admissions and 28 (3,103) deaths were above their respective 21-day averages.

In the last 24 hours, no new hot spots have been identified by ODH.

Warehouse capacity continues to be monitored as inbound supplies increase. State stockpiling and storage strategies continue to be developed through ESF-7 and the State EOC Unified Command.

# State Community Lifeline Status

# In-state Response | Ongoing External Support | Assistance Needed

Primary Lifeline

- Total confirmed cases, deaths, and hospitalizations continue to increase.
- 7-day moving average of case by onset date steadily increased from mid-June to early July.
- Positivity rate has increased slightly since late June;
- Reproduction number is now ranging between 1.03-1.12 in the three clinical zones.
- ED visits in mid-June show an increase; COVID diagnoses and total bed use continue to increase.
- Limited access to nursing homes & similar facilities continues.
- Personal Protective Equipment, Mass Fatality, and Medical Surge workgroups continue efforts.
- One RRF remains in-progress; 12 addressed and are no longer active.
- The Agriculture workgroup continues to monitor for issues of concern.
- All major pork processing plants impacting Ohio's processing are operating (statewide & nationally).
- Pork depopulation planning continues on account of processing interruption.
- Restaurants are open per the ODH Dine Safe Ohio Order (current as of May 21)
- Non-congregate sheltering planning and response continues.
- Potential quarantine locations have been identified.
- Homelessness workgroup continues to update plans for response.



- First Responders have access to information on who has tested positive for COVID-19.
- Limited access to jails & detention facilities continues.
- ODRC staff and incarcerated populations continue to test positive across their statewide facilities.

- OSHP perimeter assistance at Trumbull Correctional Institution began June 29th demobilize on 7-21-20 ONG 6 medics 1 OIC begin at TCI effective today, July 1st, demobilization July 17, 2020 demobilize on 7-17-20, reassigned to Lebanon Correctional Institution 7-19-20.
- ODRC Special Operations team members working at TCI for a security mission and LeCI for a medical mission.
- Continues to have hot spots with staff and inmate positive COVID-19, most of the hot spot institutions reflect the hot spots (counties) in the State of Ohio.

  - There are currently 726 applicants, an increase of 1 from July 14th.
  - o There are currently 83 projects submitted, an increase of 0 from July 14th.

#### Actions Taken:

- o There are Pop-Up Testing Sites today through Sunday (July 19) in Cincinnati.
- Today, Gov. DeWine noted that 19 Ohio counties have been identified as in Red Alert Level 3 Public Emergency:
  - Butler (off Watch List), Cuyahoga (off Watch List), Hamilton (off Watch List), Clermont, Fairfield, Franklin, Pickaway, Lorain, Montgomery, Summit, and Wood
  - NEW to Level 3: Allen, Athens (on Watch List), Delaware, Licking, Lucas, Richland, Scioto, and Union
  - 36 Ohio counties are at Level 2 Public Emergency Increased exposure and spread
  - 33 Ohio counties are at Level 1 Public Emergency Active exposure and spread
- Gov. DeWine announced a \$20 million grant funding through Ohio Dept. of Development to help Ohio manufacturers produce much-needed PPE.
- Lt. Gov. Husted noted that Ohio has procured approximately 65 million pieces of PPE. More than 50 million pieces of this PPE have been distributed across the state


- The Ohio National Guard has 937 people supporting COVID operations today.
- An ONG logistics officer participated in a multi-agency site survey of the RSS and Adelaide warehouses to evaluate PPE storage options.
- ONG received a request to transfer the 7 person medical team from Trumbull CI to Lebanon CI, starting Sunday, 19 July.
- 496 ONG personnel are supporting food banks around the State of Ohio.
- 2 specialists work in the ODH Labs.
- 242 medical professionals are part of the sample collection teams. 7 medics are caring for the inmates of Trumbull Correctional Institution.
- o 20 pax are working in the RSS warehouse moving PPE.
- o 24 persons are working the PPE overflow warehouse at the state Expo Center.


