

## **Executive Summary**

ODH confirmed additional cases across the state, with cases now being confirmed in 16 of the state's counties. The State Emergency Operations Center (EOC) remains Partially Activated, with Emergency Support Functions 5, 7, 8, 13, and 15 being required at the EOC. Operational and planning efforts were focused on public information & warning, healthcare systems support, responder security and protection, and private sector coordination.

The State EOC continued to process and address mission requests from County EMA partners, including requests for disinfectants, personal protective equipment, State EOC liaison support, and requests for information.

Requests for Personal Protective Equipment (PPE) are being received and initially processed by the State EOC. Assignment and fulfillment of PPE missions will occur as prescribed by Ohio Department of Health guidance once it is finalized.

## National Emergency Declaration for COVID-19

Under this National Emergency, the President has given authority to the Secretary of HHS to waive or modify certain requirements of the Medicare, Medicaid, and State Children's Health Insurance programs and of the Health Insurance Portability and Accountability Act Privacy Rule. Additionally, the President enacted certain authorities under the Stafford Act. HHS is still the Lead Federal Agency and FEMA is in a support role to HHS. The declaration enhances FEMA's authority to support HHS.

#### Actions Taken:

- Ohio Department of Health
  - o ODH participated in a Quarantine Housing Workgroup meeting.
  - ODH participated in the COVID-19 Persons experiencing homelessness workgroup.
  - ODH conducted Mass Fatality Planning conference call today with our ESF-8 partners.
  - o ODH participated in Food Safety conference call.
  - ODH is participating in Long Term Care meeting today with Aging and Ombudsman personnel
- Ohio Department of Aging and State Long-Term Care Ombudsman
  - The State Ombudsman continued to communicate with regional ombudsman programs frequently. They've shifted to remote complaint handling for nursing home complaints and are attempting visits to residential care facilities and group homes.
  - Ombudsmen participated in a teleconference with ODMHAS on 3/17/20 regarding face-to-face communication with group home residents.
  - ODA continued to support working groups including: Quarantine Housing, Mass Care, Transportation; Homeless Workgroup; and the LTC Workgroup.
- Ohio Department of Developmental Disabilities
  - Updated and tested of Department's mass communication system (One Call Now) and encouraging system participation.
  - o Continued deployment of telework equipment to departmental staff.
  - Continued Cross training of staff for back filling of essential job functions.
  - Suspended Ohio Developmental Disability Profile (ODDP) assessments for Intermediate Care Facilities.
  - Waived Individual Assessment Form (IAF) through June 30th reporting period.
- Ohio Department of Mental Health and Addiction Services
  - Agency coordinated with partners and key stakeholders. Giving ODH guidance and coordinating needs back to EOC.
- Ohio EMA Mass Care
  - Coordinated with partners and sorting through requests coming in. Most are able to be handled directly.
  - Worked with OHNG on mission analysis request from last week.
  - Coordinated with quarantine workgroup meeting with homeless.
  - Worked with group and planned to integrate into director Criss's work group for a conference call this morning.
