Executive Summary

ODH-confirmed COVID-19 cases and hospitalizations continued to trend upward. According to ODH, 83 of the 351 confirmed cases are currently hospitalized. On March 21, ODH provided notice to Local Health Departments to prepare a primary personal protective equipment drop-off location as the state prepares to deliver materials. Allocation information will not be available until March 23; the State EOC will send this information as it becomes available.

The State Emergency Operations Center (EOC) remains Partially Activated, with Emergency Support Functions 5, 7, 8, 13, and 15 being required at the EOC. Operational and planning efforts were focused on public information & warning, healthcare systems support, responder security and protection, and private sector coordination.

The State EOC continued to process and address mission requests from County EMA partners, including requests for personal protective equipment, medical equipment, State EOC liaison support, and requests for information.



National Emergency Declaration for COVID-19

On March 13, 2020, a federal emergency disaster was declared for the Public Assistance Program. This declaration is limited to costs incurred by state and local government and in very limited circumstances, non-profit organizations, for Category B, emergency protective measures.

On March 19, 2020, U.S. Small Business Administration (SBA) has approved Ohio's request to allow small businesses and nonprofits in Ohio to apply for low-interest, long-term loans of up to \$2 million through the SBA's Economic Injury Disaster Loan program.

- Regional ombudsman will follow-up with nursing facility regarding resident concerns.
- ODA will continue to work with MHAS on trauma-informed care and self-care direct messaging.
- Ohio Department of Mental Health and Addiction Services

Actions Taken:

- MHAS Trauma Informed Care team working with Ohio Department of Aging to support staff and residents at nursing homes with residents testing positive for COVID19
- o MHAS Regional Psychiatric Hospitals (RPH) finalized quarantine and isolation protocol for use in all six RPHs.
- ADAMH Boards and emergency shelter providers requested designation as essential services in the event that a shelter in place order is given and travel is limited to only essential services.
- Ohio Pharmacy Services confirmed with manufacturers that there are no immediate or long-term supply chain concerns with medications for the treatment of addiction and serious mental illness.

Planned Actions:

- MHAS working with Ohio Hospital Association to navigate what would be needed for movement of psychiatric patients from general hospital to private psychiatric hospitals if general hospital capacity needed for expanded physical healthcare capacity.
- Department has asked the county ADAMH Boards to prioritize distribution of remaining FY20 allocations to support work underway without disruption in funding, and establish remote access/coordinate with local emergency services to support local behavioral health crisis response. This is an ongoing discussion.

Ohio Department of Developmental Disabilities

Actions Taken

- Provided guidance communication for Day Service group size reduction and alternative location planning to stakeholders.
- DODD Support Teams have were created and are available to help County Boards and providers. These teams include Community Resource Coordinators (CRC), the Office of System Support and Standards (OSSAS), Community Life Engagement (Policy-CLE), and regional liaisons for dual diagnosis in mental illness and intellectual disabilities (Policy-MI/IDD).

Planned Actions:

 Continuing working closely with Ohio's County Boards of Developmental Disabilities, the Ohio Department of Medicaid, and the Centers for Medicare and Medicaid (CMS) to establish funding mechanisms that will assist providers to maintain at least baseline operations.

- o Created a frequently asked questions document, and a brief (three pages) on the order. This was added, along with the actual order to a newly created section on the coronavirus.ohio.gov website specifically about the Stay At Home order.
- Call center scripts were updated so they could field questions on the new order.
- Melanie and Arundi spoke with four local health departments to advise them on their communications.

- o Create guidance for daycares, senior centers, and the pharmacy orders.
- o Focus on increasing materials for non-English speakers.
- o Increase resources on the Stay At Home section of the website.


