Executive Summary

ODH-confirmed COVID-19 cases, hospitalizations, and deaths continued to trend upward. According to ODH, 802 (+123) of the 2,902 (+355) confirmed cases are currently hospitalized.

Alternate Care Site location assessments continue at the local level, being conducted by County EMAs and healthcare regions in preparation to meet medical needs associated with projected hospitalization surge. Potential locations will be evaluated by the Joint Engineering Assessment Teams (led by Ohio National Guard) to determine final suitability.

Workgroups continue to plan for assessed medical surge, personal protective equipment, quarantine, and congregate care needs. Guidance on the use of Higher Education Facilities for COVID-19 Response was provided by the Quarantine Workgroup to County EMAs.



Update: Began drafting statewide strategy for fatality management, to include OMORT operations. Three Disaster Mortuary Operational Response Team subject matter experts are being requested from FEMA. The group continues to identify burial best practices and staffing needs to support operations.

County EMAs, local health partners, and state-led Engineer Assessment Teams are coordinating site assessment and approval.

 - The appeal suggests that HEIs look for PPE in such areas as biology, chemistry, and environmental programs that include research labs and field work; ceramic studios that commonly use N95 respirator masks when handling raw materials; hazmat training programs; and health clinics and/or nursing programs.
- If HEIs have PPE to donate, they can contact their local healthcare facilities or county Emergency Management Agency.
- Facilitated a COVID-19 Update conference call with Ohio's 112 local health departments that drew 850 participants. Informed local health departments about lab testing and where to find current information.
- o Mission approved for lab assistance from OHNG 52nd CST civilian support troop
- Department of Rehabilitation and Corrections COVID testing process: complete.
- Working on procurement of hydroxychloroquine.
- Discussed planning and resources needed to advance fatality management with Ohio EMA.
- Participated in a call with the Department of Commerce and the Ohio Funeral Directors Association to discuss best practices for burials.
- Participated in two Long Term Care Strike Team Calls:
 - Altercare of Alliance LTC Facility (Stark Co.)
 - Atria Northgate Park LTC Facility (Hamilton Co.)

- Planning the pickup of the deployed mobile cooling unit from the Franklin County Coroner's Office Saturday.
- A COVID-19 staffing survey has been shared with eleven (11) licensing boards, for dissemination to their licensees and contacts: In addition to the seven (7) mentioned yesterday, four (4) additional Boards have been provided the survey.
 - The purpose of this survey is to identify additional licensed personnel who could support potential hospital and behavioral health surge from COVID-19.

Planned Actions:

- Continue to monitor Statewide Hospital Resource Utilization Statistics including hospital bed availability.
- State Long-Term Care Ombudsman/ Ohio Department of Aging

Actions Taken:

- The ombudsman is now monitoring 25 long-term care facilities impacted by COVID-19.
- State Ombudsman and ODA facilitated long-term care strike team calls in Hamilton and Stark Counties.
- State Ombudsman convened the inter-agency resident transition team to update partners on evacuations
- ODA is distributing \$8.8 million across the state to meet the growing demand for meal assistance by older Ohioans impacted by COVID-19.
 - ODA will be distributing the funds, provided through the federal Families
 First Coronavirus Response Act, to the state's 12 regional Area Agencies on
 Aging (AAAs) to support meals programming for older Ohioans at highest
 risk for malnutrition and hunger.
 - AAAs will prioritize these funds to those most vulnerable.
 - This funding should significantly expand home-delivered and other meals programming.
 - AAAs may use this funding to address waiting lists, expand the number of people receiving home-delivered meals (including those that previously participated in congregate meals), and provide additional meals per day or week.

Planned Actions:

 SLTCO/ODA will facilitate a second Long-Term Care Strike Team call in Stark County and will participate in a Miami County call on April 3.

- ODA will present the weekly webinar for Area Agencies on Aging to provide updates and guidance.

- DODD is asking providers and provider associations to complete a resource inventory template to gain an understanding of the resources available and those needed to help triage residential provider supply and capacity issues.

- o Participated in regional IV teleconferences with FEMA and HHS.
- Coordinated behavior health support to the EOC
- Assistant Director of Community Treatment and Recovery Services met with the EOC manager to identify support needs at state EMA and the EOC.

- Behavioral health services to come to the EOC.
- Providing helping materials, crisis information and referral information.
- On-site messaging that could include crisis text lines and other communication.

- FEMA has approved statewide non-congregate sheltering.
 - Local governments who are engaged in non-congregate sheltering in response to the COVID-19 pandemic, do not need to seek approval from FEMA before doing so (again, this FEMA approval was for reimbursement purposes only and not operational).
 - Local governments that engage in non-congregate sheltering should track costs and be prepared to submit those costs to FEMA as part of their Public Assistance Grant, DR-4507.

Planned Actions:

- The focus over the next 24 hours is continuing to enter Requests for Public Assistance into FEMA's Portal.
- An additional FAQ, adding information on tracking donated resources to help offset the local match will be provided; required contract provisions and eligibility of child care costs.

- EOC placed request to determine if any pharmacies could deliver to any "surge locations."
 - Provided resource guide to EOC staff.
 - Shared with Quarantine Workgroup, Transportation Workgroup, and to our 2-1-1 partners.
 - Also posted as a position log so any partners can use as a resource.
- Directed potential resource partners to together@governor.ohio.gov.

Planned Actions:

- The initial 45-day emergency declaration expires on May 6, 2020. The 45 days are separate for the activation of the event and the credentials themselves. Meaning, the issuance of the credential and the event are an independent 45 days. This could cause confusion for users whose credentials expire before May 6 as well as after.
 - A plan to address this situation is being drafted.
- Working to schedule an OP3 partner call for Friday at 1:00PM to provide updates on COVID-19 and requests for assistance.
