# **Executive Summary**

Over the past 24 hours, deaths (+50), hospitalizations (+123), and ICU admissions (+41), were all higher than the five-day average, while the increase in new cases (+305) was lower than the five-day average. According to ODH, 2,156 of the 7,280 confirmed cases have been hospitalized.

State EOC Workgroups continue to plan and support County EMA efforts in the realms of protective equipment, medical surge, mortuary services, quarantine plans, congregate care, and homelessness.







- Coordinated with ODH to provide 10,000 gowns from the RSS warehouse & will provide 17,000 N95, 7,740 UVEX 2200 dust masks & 36,300 Ear loop masks from donations warehouse to address emerging hotspot in prison system.
- DAS sourced supplies necessary to stand up a 150 bed ACF at the Duke Energy Center in Cincinnati and worked to source requested thermometers and hospital & cleaning supplies
- DAS also continued to source and vet PPE for potential purchase.
- o Researched & purchased 150,000 gowns yesterday.
- Worked with two local companies wanting to donate PPE, totaling just over 122 individual/business like donors.
- Worked with ESFs 1, 7, & 8 on PPE donated items
- Working future logistics for pre-planning missions.
- Worked with ODH warehouse on delivery dates.

#### **Planned Actions:**

- o Continue to source PPE & work WebEOC missions.
- Prepare controlling board request for the next two weeks, continue to research and purchase from vendors for PPE.
- Continue to work with Governor's Office and ODH warehouse on delivery dates.

#### 8 | Public Health

• Ohio Department of Health

Status Update (By Healthcare Region)

- o Northwest:
  - Hospitals are continuing to update SurgeNet twice daily and the OHA Resource Tracker once daily. Many regional hospitals are working with local long-term care providers to prepare for potential outbreaks.
- o Northeast:
  - Supported the Region 2 & Zone 1 surge planning calls with Cleveland Clinic as lead. Will be discussing with PH how to support regional PH efforts for NH & prison/jail expected clusters & spikes over the next few months. Had a Chempack Call with ODH & Metrohealth to see of the feasibility of utilizing some of the Chempack meds in the face of short supply at hospitals. Follow up call later this week. Held evening EM call.
- Northeast Central:
  - St. Elizabeth Youngstown Hospital reported 55 confirmed COVID patients, which was the largest count in the region yesterday. Most hospitals are reporting lower than normal ED volume & are on full lockdown, allowing no visitors.
- o Central:
  - Situation Reports were prepared twice a day. Participated in CMO call.
- Southeast / Southeast Central:
  - Continue to expand the SE/SEC Regional Surge Plan.
  - SE/SEC hospitals who requested beds through their local EMA to expand their internal hospital surge capacity will likely receive these beds this week.
     Local EMA is working with the Ohio National Guard to coordinate with local EMAs for shipment.
  - RHC hosted a SE/SEC region hospital call yesterday at 12:00 p.m. with some EMA partners & Regional Public Health Coordinators. Information was shared regarding use of the Chempack in last resorts for life saving treatment of COVID patients. Reviewed the process for requesting the Chempack as well. Share information regarding the development of the Columbus Convention Center and transfer process. All SE/SEC region hospitals reported no ED surge, low inpatient status, & continued PPE challenges.
  - Began discussions on Mass Fatality Planning. SE/SEC looking at resources needed & working with their local coroners to review their plans. Looking at their cache body bags to determine the quality. A regional plan was shared with the hospitals.
- West Central:
  - Request from Kettering Heath Network for assistance with testing supplies.

#### o Southwest:

- Gather & report data as requested for the Ohio Department of Health.
- Task force determined SW region will begin updating bed availability on surgenet every 4 hours 24/7 beginning 4/4/20. Assisting with Surge Net access requests from hospitals, rehab facilities, transportation workgroup and EMS when requested.
  - Continued to refine number of additional med/surg & critical care beds in hospitals. Will use this information to determine when thresholds are met to move to next level of surge.
  - Defining thresholds and actions for each level of surge
  - Workgroup timelines established.
  - Triage/Transport workgroup process & flyers being distributed to hospitals.
- Task Force/Steering Committee Update:
  - 4/12/20 Meeting Suspended
- Additional operational workgroups: Data, Supply Chain, PIO, SNF, Outlying/Specialty Hospitals, Vulnerable Populations, Transportation, Clinical Protocols, ACS (Duke and Liberty), Psychiatry, Crisis Standards of Care The Health Collaborative leveraging staff resources for project management and support of work groups.

- Planning is underway with OSU and Federally Qualified Health Centers regarding how to access the populations in most need with resources and supplies when they become available.
- The Ohio Department of Higher Education is drafting a memo with the Ohio
   Department of Health to address the off campus housing college residents to ensure
   they remain compliant with social distancing order.
- Participated in Quarantine Call
- Participated in FEMA/LNO Call.
- Gathered Long Term Care Facilities (LTCF) data for post on the website, per governor's order.
  - This will be posted on Wednesdays.

- Participated on-site visits to areas of concern with CDC Team.
- o Creating a method for local health departments to report LTCF data in future.
- Continued drafting communications to subject matter experts in various state agencies to seek feedback on regional public health guidelines/precautions during regional "flare ups" in COVID-19 cases when Ohio begins to relax pandemic restrictions.
  - Communications will be reviewed and approved prior to dissemination.
- Sent volunteer agreements and training to OU med student volunteers.
- Sent message through the Association of Ohio Community Health Centers inviting them to submit request for volunteer support ODH continues to work with the Fatality Management Workgroup daily in advancing the plan and statewide strategy.
- The Ohio Board of Funeral Directors and Embalmers, Ohio Funeral Directors
   Association, Medical Board, the Cincinnati College of Mortuary Sciences and DRC representatives met to discuss the development of decedent transfer guidance.

- 6. Purchase 1,000,000 sets of PPE weekly until the surge occurs
