Executive Summary

Over the past 24 hours, total new cases (+577), hospitalizations (+78) and ICU admissions (+20) were all below five-day averages, while total deaths (+46) were slightly above the five-day average. 2,960 of the 14,694 total cases have been hospitalized.

The State EOC continued to identify, monitor, and respond to COVID-19 hot spots, with a strong focus on Long-Term Care facilities and incarcerated populations. There are now 346 (+15) confirmed cases of staff members and 3,816 (+54) confirmed cases of incarcerated adults in Ohio's prisons. One staff member and 15 incarcerated adults have died due to COVID-19.

At the Northwest Ohio Developmental Center in Toledo, 36 staff members and six residents have tested positive, and one resident has died due to COVID-19.




