Executive Summary

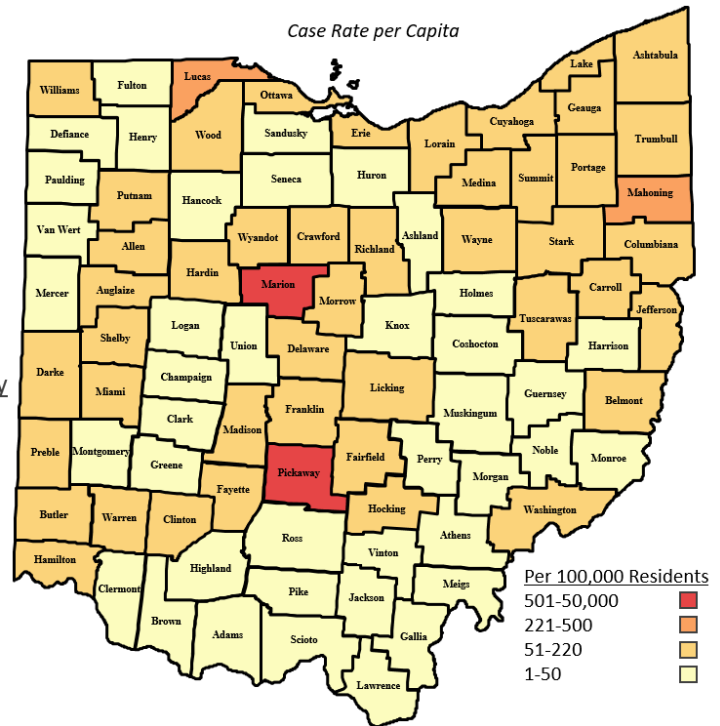
Over the past 24 hours, total new cases (+444), hospitalizations (+108), deaths (+46), and ICU admissions (+26) were above the 5-day average. 3,340 of the 16,769 total cases have been hospitalized over the course of this incident. Current models show current medical capacity capable of handling COVID-19 caused stressors.

The State EOC continued to plan for cascading effects to the Food, Water, and Shelter Lifeline, with impacts to the food distribution system being the primary focus. Additionally, ongoing coordination regarding PPE state receipt and distribution to medical, congregate care, and critical infrastructure sectors occurred. Efforts also continued to identify, monitor, and respond to COVID-19 hot spots, with a strong focus on Long-Term Care facilities and incarcerated populations.

Primary Lifeline



- Total confirmed cases, deaths, and hospitalizations continue to increase.
- Statewide bed and ventilator capacity are projected to meet 30-day medical forecast needs.
- Forecast PPE needs continue to drive state procurement efforts.
- 36 staff members and six residents at Northwest Ohio Developmental Center have tested positive.
- Six staff members at Twin Valley Behavioral Healthcare Hospital have tested positive.
- Mass Fatality, Medical Surge, and Personal Protective Equipment workgroups continue efforts.
- One local Alternate Care Site (Population: 0) is operational in Columbus for Med Surge needs.
- An Attentive Care Site (Population: 0) has been established in Columbus to address Mass Fatality needs.

Status Update:

- Zone 1 (Northwest, Northeast, Northeast Central)
 - Some regional hospitals are demobilizing outdoor tent triage areas and alternate patient care areas within their facilities. Plans are in place to rapidly open these areas in the event that a surge occurs. Facilities are also developing plans to resume conducting elective surgeries. Low patient censuses are allowing for terminal cleaning of some patient care areas.
 - Supported Zone 1 call. Held evening Emergency Manager Call.
 - Cleveland Clinic Akron General seeing a small increase in patients. Not connected to any particular hotspot. Positive patient numbers remain steady at other facilities and some see a decline.

- Zone 2 (Central, Southeast, Southeast Central)
 - Attended the CMO call yesterday. The Franklin County CMOs will meet later in the week to create a coordinated system plan for elective surgeries.
 - Discussion on the ACS at the GCC and how long to leave it set up. The GCCC Task Force team will meet once a week for the next 2-3 weeks to discuss the need. It would be a mistake to take it down too soon; before things start to open up and it may be needed again.
 - RHC participated on daily Surge Conference Call with OSU, OhioHealth, MCHS, Trinity, and Adena to discuss transfer process and surge capacity.
 - Hosted Monday SE/SEC Region Hospital conference call. Discussed changes in reporting. Hospitals will not be required to report to COHDIMS or SurgeNet on Saturday and Sunday's in the PM. AM updates will continue. Shared ASPR funding announcement.

- Zone 3 (West Central, Southwest)
 - Miami Valley North removed the tent they were using to segregate the respiratory patient coming to the ED. Assessing ED census per previous 24 hours. No current surges in numbers.
 - Gather and report data as requested for the Ohio Department of Health.
 - Task force determined SW region will begin updating bed availability on SurgeNet every 4 hours 24/7 beginning 4/4/20. Assisting with Surge Net access requests from hospitals, rehab facilities, transportation workgroup and EMS when requested.

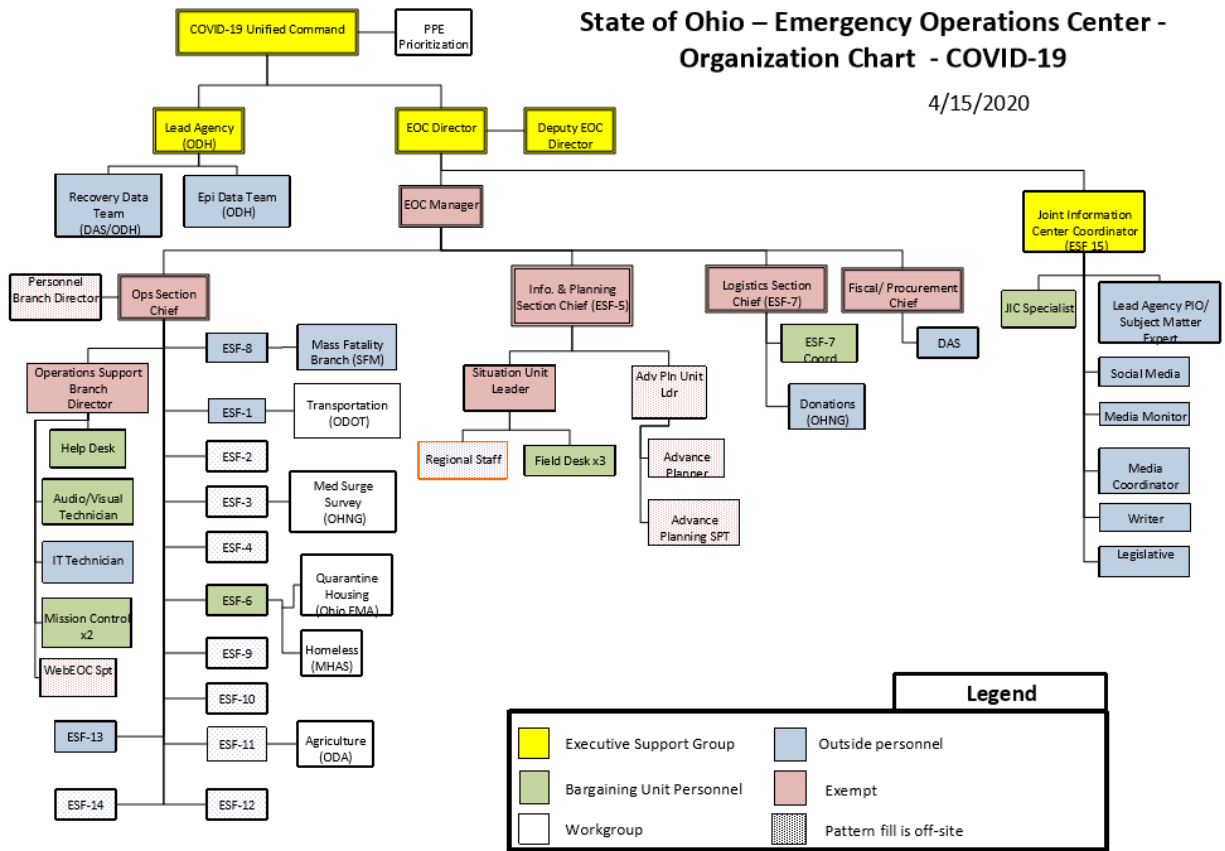
