
### **Executive Summary**

The Ohio Department of Health reports that that 636 (26,357) total new cases, 100 (4,718) hospitalizations, 20 (1,268) ICU Admissions, and 51 (1,534) deaths have been documented. All reported numbers were above their resptive 21-day averages.

Clincil Zone reporting shows a decrease of COVID patients on ventilators, but an increase in the acuity of non-COVID admissions. This increase is assessed to be associated with patients taking action on delayed treatments.

Personal Care Services are re-opening today as a part of Ohio's Responsible Restart Ohio plan. Cascading effects continue to be monitored and identified. There are no ongoing significant impacts to critical infrastructure.

A statewide push of cotton masks will be conducted today. An additional PPE push has been approved for the week of May 17.


