

### **Executive Summary**

Over the past 24 hours, ODH reported 498 (28,952) total new cases, which was below the 21-day average. 63 (1,720) deaths, 119 (5,117) hospitalizations, and 29 (1,357) ICU Admissions metrics were above their respective 21-day averages. Governor DeWine lifted the "Stay Safe Ohio" order as well as travel restrictions.

County PPE needs were assessed after all 88 County EMAs provided forecast type and size to help focus future allotments. A second allotment is scheduled for delivery on May 20. Additional warehouse space is being sought as in-use locations are near capacity.

Up to two and a half additional inches of rain were received by Southwest Ohio. Multiple evacuations due to high water were handled locally without the need for State EOC support. Interstates in Franklin County are currently closed due to inundation. Multiple U.S. and State Routes are closed across the state as water begins to recede.

- The RSS Warehouse is operating at maximum capacity and can only accept federal shipments and state procured shipments based upon the number of pallets pushed out daily.
  - All inbound shipments that will put the RSS over capacity will be diverted in coordination with ESF-7 for alternate storage until additional capacity becomes available at the RSS.
- The RSS Warehouse has received five inbound shipments of VTM, 3D printed swabs, flocked swabs, face masks, surgical gowns, and isolation gowns.


