### **Current Situation:**

Public Health – Dayton & Montgomery County, the Ohio Department of Health (ODH) Centers for Disease Control and Prevention (CDC) and World Health Organization (WHO) are closely monitoring an outbreak of respiratory illness caused by a novel (new) coronavirus (termed "COVID-19") first identified in Wuhan City, Hubei Province, China in December 2019 and which continues to expand.

# **Current Updates:**

- MOST IMPORTANT MESSAGE OF THE DAY: DO EVERYTHING YOU CAN TO CONSERVE PERSONAL PROTECTIVE EQUIPMENT (PPE).
- Globally the World now has 3,807,852 cases and 269,068 deaths from COVID-19.
- Governor DeWine announced the following areas would be opening in the next week:
  - Hair salons, day spas, nail salons, barbershops & tanning facilities open May 15
  - Restaurants and bars with outside seating areas can open on May 15<sup>th</sup>
  - o Restaurants and bars can fully open with inside seating beginning on May 21<sup>st</sup>
  - Specific information on requirements for opening at these locations can be found at <u>coronavirus.ohio.gov</u>
- <u>All</u> the elastic for completing the refurbishing of N-95s has arrived on site.
- The county received another Strategic National Stockpile delivery on Wednesday and will receive another delivery Monday, May 11, 2020.
- Public Health will facilitate a conference call with congregate locations on Monday, May 11<sup>th</sup> at 9 AM.
- Kroger drive-through clinic will be open next Tuesday through Thursday at Southview Medical Center.



- The virtual EOC has begun to scale back some positions within the EOC but will continue to support purchasing and ESF#8.










# **Regional Breakdown of cases:**

# Highlights

WHO launched a checklist to support prison administrators and policy-makers for rapid and effective response to COVID-19.

WHO is supporting several African countries to coordinate and reinforce the work of emergency medical teams (EMTs) deployed to support the efforts to contain the spread of COVID-19 pandemic.

The WHO Regional Director for Europe, Dr. Hans Henri P. Kluge stated his concern about the increase in interpersonal violence during COVID-19, and emphasized that "violence is preventable, not inevitable".

At the third meeting of the International Health Regulations (IHR) (2005) Emergency Committee for COVID-19, the WHO Director-General reaffirmed that the outbreak of COVID-19 continues to constitute a public health emergency of international concern and issued the Committee's advice to States Parties as Temporary Recommendations under the IHR. Today we celebrate the 40th anniversary of the Declaration of Smallpox Eradication by the 33rd World Health Assembly. In the 'Subject in Focus' below, we look at how the global community came together to eradicate one of the most feared diseases of all time and how we can learn from this experience to fight COVID-19 today.







#### Cases & Deaths by State


22 states report more than 10,000 cases of COVID-19.
