
Executive Summary

Over the past 24 hours, ODH reported 429 (40,004) total new cases and 60 (6,753) hospitalizations were below 21-day averages. 18 (1,732) ICU Admissions and 33 (2,490) deaths were above their respective 21-day averages.

No new hot spots have been identified in the last 24-hours. The State EOC continues to support one previously identified hot spot through an ongoing mission. ODH continues to monitor nine hot spots.

A statewide push of PPE will be scheduled for Monday, June 15. Counties should have received the advance bill of lading.


