
### **Executive Summary**

Over the past 24 hours, the Ohio Department of Health reported 737 (51,046) total new cases 65 (7,746) hospitalizations and 15 (1,961) ICU Admissions, all of which were above 21-day averages; 11 (2,818) reported deaths were below the 21-day average.

ODH reports one additional hot spot being identified during clinical zone calls on June 29: The Trumbull Correctional Institute is experiencing an increase in confirmed cases among staff and the inmate population. The Ohio National Guard and the Ohio State Highway Patrol will begin supporting the facility by providing medical staffing and augmented perimeter security, respectively.

The 20th statewide push of PPE was conducted by the State EOC. Warehouse capacity continues to be monitored as inbound supplies increase. State stockpiling and storage strategies continue to be developed through ESF-7 and the State EOC Unified Command.

# State Community Lifeline Status

Primary Lifeline

- Total confirmed cases, deaths, and hospitalizations continue to increase.
- 7-day moving average of Case by onset date steadily increased since mid-to-late June.
- Positivity rate has declined as testing has increased; current rate is 4.7% of those tested.
- Reproduction number is now ranging between 1.00-1.18 in the three clinical zones.
- ED visits in mid June show an increase; COVID diagnoses and total bed use continue to increase.
- Limited access to nursing homes & similar facilities continues.
- Personal Protective Equipment, Mass Fatality, and Medical Surge workgroups continue efforts.
- One RRF remains in-progress; 12 addressed and are no longer active.
- The Agriculture workgroup continues to monitor for issues of concern.
- All major pork processing plants impacting Ohio's processing are operating (statewide & nationally).
- Pork depopulation planning continues on account of processing interruption.
- Restaurants are open per the ODH Dine Safe Ohio Order (current as of May 21)
- Non-congregate sheltering planning and response continues.
- Potential quarantine locations have been identified.
- Homelessness workgroup continues to update plans for response.



- First Responders have access to information on who has tested positive for COVID-19.
- Limited access to jails & detention facilities continues.
- ODRC staff and incarcerated populations continue to test positive across their statewide facilities.

#### 6 | Mass Care

#### Actions Taken:

 Ongoing mission support and partner coordination to support the Food, Water, & Shelter lifeline.

#### Planned Actions:

Participation in the Ag Work Group call and a call with ESF-7 to discuss contract staffing options for a variety of MC/EA-related tasks.

#### 7 | Logistics

Ohio Emergency Management Agency

#### Actions Taken:

- As of June 26 the expo center warehouse was at 20% capacity.
- The OHNG received six truckloads with six pallets of face shields (50,000 each) and 117 pallets of gowns (499,440).
- Indications are that inbound shipments have increased.
  - A tally of June 29 shipments will be included in July 1 sitrep contribution.
- Confirmed with FEMA V that all federal resource requests are completed or cancelled with the exception of the OHNG title 32 status and subsequent extensions.
  - FEMA informed us that there are residual PPE shipments from the PPE request.
  - o Expected number of additional trucks is 4.
- Working with CFO in the controlling board request for FY21 for CARES Act money.
- No new purchases were made today.

#### Planned Actions:

- Start back up processing invoices on July 1.
- Continue to work with the warehouse on deliveries, and with vendors on their invoices.
- Continue coordinating and warehousing inbound shipments of PPE. Continue supporting and coordinating all logistics operations related to COVID-19.

#### 8 | Public Health

- Ohio Department of Health
  - Lead Agency for PPE Workgroup
    - Purpose: To determine and allocate appropriate PPE for COVID-19 responders.
  - Lead Agency for Mass Fatality Workgroup
    - Purpose: To assemble stakeholders within mass fatality/fatality management to develop statewide strategies & unified effort in the management of decedents.
  - Lead Agency for Medical Surge Workgroup
    - Purpose: Planning for needs to address forecast Medical Surge needs.

#### Actions Taken:

- There is an increase in COVID-19 cases and hospitalizations in Zone 3, specifically in Hamilton and Montgomery counties.
  - Hamilton and Montgomery counties have more than double the COVID-19 cases in the past week.
  - Hamilton County will have seven pop-up testing sites this week.
  - Mitigation efforts include contact tracing and communication.
- The Mass Fatality Branch has received concerns regarding the timeliness of death certificate distribution in Cincinnati.
  - The workgroup is scheduled to convene Tuesday, June 30th where partners will discuss strategies for supporting the local stakeholders in alleviating barriers.
- The Ohio Department of Health, in coordination with the Ohio State Highway Patrol and Ohio EMA, supported the transfer of remdesivir within Zone 2 on Sunday.
- The State of Ohio has received notification that we will be receiving another round of redelivers.
  - Once received, the product will be allocated and distributed to eligible hospitals to be available for patient needs.
- During this operational period ESF-8 Desk has initiated two (2) mission requests today with State partners.
- The 20th PPE Push was executed.

#### **Planned Actions:**

- o ESF-8 Will be participating in the FEMA/HHS LNO Call.
- o ESF-8 partner touchpoint is scheduled for tomorrow.
- ODH continues to collaborate on daily RFIs and planning efforts with federal and state stakeholders and ESF-8 partners to provide guidance and direct information.
- Ohio Department of Education

#### Planned Actions:

- Continuing to develop new and update existing information and policy documents for schools regarding services to students during closures.
- Developing Education Reset and Restart Planning Guide and resources for schools and district.
- Ohio Department Aging, State LTC Ombudsman

#### Actions Taken:

- ODA issued the updated tool kit for long-term services and supports as a pre-surge and longer-term planning document.
- State Ombudsman participated in interview with WOIO in Cleveland regarding longterm care facility resident and family impact.

- Ombudsman followed up on evacuation of McMullen Assisted Care.
  - One resident transferred to an HCIC died.
  - The facility has been cleaned and the operator anticipates return of residents in mid to late July.

#### Planned Actions:

- Ombudsman will participate in weekly ODH/Provider Association touch point, ESF-8 touch point, and NF testing debrief.
- Ohio Department of Developmental Disabilities

#### Actions Taken:

 Warrensville Developmental Center collaborated with the Cuyahoga County Board of Health and participated in voluntary drive through testing with 91 staff participating.

#### Planned Actions:

- Continue to monitor DODD system statistics, including positive, pending, and negative cases of COVID-19 for staff and residents.
- Continue to track daily inventory and usage of PPE for the Developmental Centers.

- Perimeter security at Trumbull Correctional Institute.

- Assistance with meal delivery to seniors citizens in Preble County for "Food 4 Families".
- Assist PATH Center with meal deliveries in Defiance County.
- Ohio Department of Rehabilitation and Correction

#### Actions Taken:

o ODRC Continues to work towards incident objectives.

#### Planned Actions:

- ODRC has 793 staff COVID-19 positive, 683 staff recovered, 110 active positives and five deaths.
- ODRC has 137 incarcerated adults COVID-19 active positive, 4,252 recovered and 76 deaths, 14,368 total tested.
- ODRC has staff and/or inmate COVID-19 positives in 28 of the 28 institutions the last institution experienced a staff positive on June 21, 2020.
- ODCR continues to have hot spots with staff and inmate positive COVID-19.

#### 14 | Recovery & Mitigation

Ohio Emergency Management Agency

The FEMA Public Assistance (PA) Program is declared for COVID-19.

- There are currently 716 applicants, an increase of 1 from June 26.
- There are currently 64 projects submitted, an increase of 2 from June 26. \$22.8 remains obligated.

#### Actions Taken:

o Ohio EMA continues to provide technical assistance to PA applicants.

#### Planned Actions:

Ohio EMA will participate on the County EMA Directors call and will draft the
extension request for the statewide approval of non-congregate sheltering.

#### **Other Partners**

Ohio National Guard

#### Actions Taken:

 897 Ohio National Guardsmen support the COVID-19 response in Ohio. The Ohio National Guard has collected sample for over 37,000 Ohioans since the beginning of the sample collection mission.

June 30, 2020

- 529 guardsmen support 14 food bank missions.
- Two Guardsmen are working as specialists in ODH labs.
- 188 members are on Specimen Collection teams.
- 21 soldiers support the state RSS warehouse.
- 17 Guardsmen operate the Expo Center warehouse.

#### Planned Actions:

- The Guard will stand up four additional COVID sample collection teams to begin work July 1.
- The ONG will support medical operations at the Trumbull Correctional Institution on July 1.


