Current Situation:

Public Health – Dayton & Montgomery County, the Ohio Department of Health (ODH) Centers for Disease Control and Prevention (CDC) and World Health Organization (WHO) are closely monitoring an outbreak of respiratory illness caused by a novel (new) coronavirus (termed "COVID-19") first identified in Wuhan City, Hubei Province, China in December 2019 and which continues to expand.

Current Updates:

- MOST IMPORTANT MESSAGE OF THE DAY: DO EVERYTHING YOU CAN TO CONSERVE PERSONAL PROTECTIVE EQUIPMENT (PPE).
- Globally the World now has 5,459,528 cases and 345,994 deaths from COVID-19.
- Regional express lab at Dayton Children's officially opens today. The location will be able to generate 10,500 tests a week. It will focus on congregate locations.
- The Ohio Guard will be conducting sample collection for all staff working in nursing homes within the state of Ohio. More detail on this will come out on Thursday, May 28th at the ODH call.
- Public Health has sample collection strike teams forming to conduct testing at hotspots in the county. The first testing is scheduled for Thursday and Friday this week.
- The county will receive another Strategic National Stockpile (SNS) today and another is expected on Thursday, May 28, 2020.
- Public Health facilitated a conference call with congregate locations on Tuesday, May 26th at 9 AM.
- The following areas re-opening today and later include the following:
 - May 26 Gyms and fitness centers, protocols on website today






- o May 26 Sports leagues, non-contact or limited contact (golf, tennis, baseball, softball, etc.)
- Higher contact sports still being worked on, no date yet (lacrosse, hockey, field hockey, basketball, soccer, volleyball, gymnastics etc.)
- o May 26 Pools regulated by local health departments, not water parks or amusement parks (these are travel and tourism, still in discussion)
- May 26 BMVs, please continue online services as well
- o May 31 childcare providers can reopen with reduced numbers in classrooms and intensified cleaning
- May 31 Child day camps
- Nursing homes are projected to receive their direct delivery of PPE from the SNS this week between May 28 and 31, 2020.

- ODH information line remains open, the number is 1-833-4-ASK-ODH and is open seven days a week.
- Public Health continues to monitor all sources (ODH, CDC, WHO, European Center for Disease and Prevention and Control (ECOC) for the latest information.
- Public Health maintains its one-week operational period for this response.
- Public Health will continue to share the situational report with other local health departments, Montgomery County Emergency Management, Greater Dayton Area Hospital Association and Dayton Metropolitan Medical Response System partners.

CDC Update (Situation in the US):

CDC is closely monitoring an outbreak of respiratory illness caused by a novel (new) coronavirus named COVID-19. The outbreak first started in Wuhan, China, but cases have been identified in a growing number of other <u>international locations</u>, including the United States. CDC will update the following U.S. map daily. Information regarding the number of people under investigation will be updated daily.

CDC Response Updates:





Level 3 Travel Health Notice: Widespread ongoing transmission with restrictions on entry to the United States

CDC recommends that travelers avoid all nonessential travel to the following destinations. Most foreign nationals who have been in one of these countries during the previous 14 days will not be allowed to enter the United States.

- China
- Iran
- Most European Countries
- United Kingdom and Ireland

Level 3 Travel Health Notice: Widespread ongoing transmission without restrictions on entry to the United States

CDC recommends that travelers avoid all nonessential travel to all global destinations:

Global Pandemic Notice

Level 2 Travel Health Notice: Ongoing community transmission

CDC recommends that older adults and people of any age with serious chronic medical conditions should consider postponing nonessential travel to most global

Level 1 Travel Health Notice: Limited community transmission

CDC recommends travelers practice usual health precautions recommended for their destination.

World Health Organization Update:

The WHO Regional Office for Africa has provided training for Tanzanian health workers to equip them with skills for caring for critically ill COVID-19 patients. A total of 160 health workers in Tanzania attended a three-day virtual training session organized by the Ministry of Health and the World Health Organization.

The United Kingdom will contribute \$3.8m for the COVID-19 response in the Caribbean. The financial contribution to the WHO Regional Office for the Americas will help Antigua and Barbuda, Belize, Dominica, Grenada, Guyana, Jamaica, Saint Lucia, and Saint Vincent and the Grenadines contain the spread of the disease and mitigate its impact.

WHO has partnered with Vital Strategies and other global partners to launch a new technical package: Revealing the Toll of COVID-19: A Technical Package for Rapid Mortality Surveillance and Epidemic Response. This is a technical package for rapid mortality surveillance and epidemic response to support national governments with surveillance and response planning surrounding COVID-19.






Cases & Deaths by State


30 states report more than 10,000 cases of COVID-19.
