
# **Executive Summary**

Over the past 24 hours, the Ohio Department of Health reported 805 (57,956) total new cases, 77 (8,249) hospitalizations, and 19 (2,077) ICU Admissions, all of which are above their respective 21-day averages. ODH also reported 16 (2,927) deaths, which is below the 21-day average.

In the last 24 hours, ODH reported a significant rise in cases within Columbiana County associated with the Federal Correctional Institution (FCI) Elkton and positive test results among staff members were identified at Kings Island in Warren County. ODH continues to monitor 15 previously-reported hot spots. The State EOC continues to carry out ongoing missions in the form of medical and security staffing to one previously identified hot spot.

Warehouse capacity continues to be monitored as inbound supplies increase. State stockpiling and storage strategies continue to be developed through ESF-7 and the State EOC Unified Command.




