Current Situation:

Public Health – Dayton & Montgomery County, the Ohio Department of Health (ODH) Centers for Disease Control and Prevention (CDC) and World Health Organization (WHO) continued to respond to the COVID-19 Pandemic.

Current Updates:

- It needs to be continually enforced that we are still in the middle of a pandemic. Enforce social distancing, hand-washing and the wear of masks.
- Globally the World now has 52,143,259 cases and 1,284,610 deaths from COVID-19.
- Public Health pop-up testing on November 10, 2020 tested 934 individuals.
- Governor DeWine stressed the need to flip the upward trend downward. If this does not happen this could lead to bars and restaurants closing again.
- We are looking to schedule additional pop-up testing the first week of December.
- Public Health like other health departments is overwhelmed at the level of contact tracing cases. Currently reviewing options on prioritizing cases.
- Pfizer COVID-19 vaccine proves 90% effective in latest trials.
 - This is strictly information coming from Pfizer and not a peer-reviewed medical journal
 - Was 90% effective on nearly 44,000 participants
 - Two doses at 3 weeks apart
- Cases continue a dramatic upward trend within the county, region and state.
- Ohio set its largest one-day total of 7,101 cases Today, November 12, 2020.
- 68 counties as of today fall under a level 3 (red) category.
- Montgomery County remains at a level 3 (red) category.



- The positivity rate within Montgomery County is currently at 11.3%.
- Montgomery County currently has 520.2 cases per 100,000 population, placing us at 19th in the state.
- All 88 counties within Ohio continue to fall under a high incidence county based on having more than 100 cases per 100,000 population.
- Travel advisory issued: Individuals traveling to Ohio from 12 states urged to selfquarantine for 14 days.
 - These include Montana, Idaho, North Dakota, South Dakota, Wyoming, Iowa, Kansas, Utah, Pennsylvania, Wisconsin, Mississippi and Alabama
 - Five states have greater than a 40% positivity rate to include South Dakota with a high of 54.7%.

- Governor DeWine is conducting calls with key partners in each county on ways to improve the response. He is currently working his way down the case rates by county.
- The Public Health COVID-19 informational phone line remains open Monday through Friday to answer general questions. The info line is 937-225-6217.
- ODH information line remains open, the number is 1-833-4-ASK-ODH and is open seven days a week.
- Public Health continues to monitor all sources (ODH, CDC, WHO, European Center for Disease and Prevention and Control (ECOC) for the latest information.
- Public Health maintains its one-week operational period for this response.


