# **Current Situation:**

Public Health – Dayton & Montgomery County, the Ohio Department of Health (ODH) Centers for Disease Control and Prevention (CDC) and World Health Organization (WHO) continue to respond to the COVID-19 Pandemic.

# **Current Updates:**

- It needs to be continually enforced that we are still in the middle of a pandemic. Enforce social distancing, hand-washing and the wear of masks.
- Globally the World now has 62,757,540 cases and 1,460,477 deaths from COVID-19.
- Montgomery County is now a level 4 (purple) category.
- Public Health will conduct pop-up testing tomorrow, December 1<sup>st</sup> at the Montgomery County Fairgrounds. It will run from 12 PM to 5 PM.
- Vaccine is projected to arrive in mid-December. Initial deliveries will be limited and will focus on specific groups yet to be finalized.
- Pharmaceutical companies that are nearing release of vaccine are Pfizer, Moderna and AstraZeneca.
  - Pfizer & Moderna have an estimated vaccine efficacy of 95%
  - AstraZeneca showed a vaccine efficacy of 90% in one study and 62% in another study. Based on the numbers between the two groups it averaged out to 70%
  - Waiting on federal government to greenlight one or more vaccines
- 4 counties now fall under a level 4 (purple) category.
- 75 counties as of today fall under a level 3 (red) category.
- The positivity rate within Montgomery County is currently at 17.1%.
- The remaining positivity rates for the rest of the region are listed below:



- Montgomery County currently has 817 cases per 100,000 population, placing us 27<sup>th</sup> in the state.
- All 88 counties within Ohio continue to fall under a high incidence county based on having more than 100 cases per 100,000 population. Case rates range with a high of 1,140 and a low of 293.4.
- Travel advisory issued: Individuals traveling to Ohio from 16 states urged to selfquarantine for 14 days.
  - These include Montana, Idaho, North Dakota, South Dakota, Wyoming, Iowa, Kansas, Utah, Pennsylvania, Wisconsin, Mississippi, Alabama, New Mexico, Tennessee, Oregon and Arizona
  - Four states have greater than a 40% positivity rate to include Wyoming with a high of 57.3%.

- The Public Health COVID-19 informational phone line remains open Monday through Friday to answer general questions. The info line is 937-225-6217.
- ODH information line remains open, the number is 1-833-4-ASK-ODH and is open seven days a week.
- Public Health continues to monitor all sources (ODH, CDC, WHO, European Center for Disease and Prevention and Control (ECOC) for the latest information.
- Public Health maintains its one-week operational period for this response.

#### Key Points:

- Montgomery County's average daily COVID-19 case count was the highest it has been on 11/25/20 (412 cases per day).
- The highest incidence in reported COVID-19 cases occurred on 11/23/20 (595 cases).
- The current case rate increased 6% in the past two weeks from 1,268 (on 11/16) to 1,345 cases per 100,000 (on 11/30), indicating
  increased community spread.

### **Current Objectives:**

- 1. Limit the spread of disease within Montgomery County.
- 2. Continue to monitor the situation in conjunction with the Ohio Department of Health and the Centers for Disease Control and Prevention.
- 3. Continue information sharing with partners.
- 4. Continue to provide information to the media and the public through interviews, social media and our website.
- 5. Prepare for mass vaccination campaign.
