

### **Executive Summary**

In the last 24 hours, the Ohio Department of Health reported 7,981 (792,938) total new cases, 49 (6,237) ICU admissions, 100 (9,802) deaths, and 486 (41,863) hospitalizations.

The State EOC is currently at Partial Activation as it continues to coordinate response to COVID-19. While the EOC is available for use by all Emergency Support Functions, ESFs 1, 5, 6, 7, 8, 11, 13, 14, and 15 will remain activated for the ongoing response.

      - Pop-Up Testing in Marysville at the Union County Fairgrounds.
      - Ohio COVID-19 numbers for January 12: ODH reports 7,981 new COVID cases. Total cases: 792,938. There were 100 COVID-related deaths reported. Total number of COVID-related deaths: 9,802. ODH also reports 486 new hospitalizations, including 49 new ICU patients.
      - Gov. DeWine and Lt. Gov. Husted held a COVID-19 Update press briefing today:
        - Gov. DeWine noted that COVID-19 are available in limited supply, but the state is still focused on accomplishing its three goals to: Save lives, protect those in the healthcare field, and to get children back in school.
        - Vaccination in Ohio's two Veterans Homes: In Sandusky: 92% of veterans and 60% of staff chose to be vaccinated. In Georgetown: 92% of veterans and 42% of staff chose to be vaccinated.
        - 85% of nursing homes in Ohio have been visited by vaccine providers and given the opportunity to receive the vaccine.
        - Ohio hospitals have been vaccinating their medical personnel as part of Phase
           1A. Hospitals must finish vaccinating their frontline healthcare providers by

midnight on Sunday, Jan. 17. On Monday, Jan. 18 they must move to vaccinate older Ohioans who are 80 years or older, as part of Phase 1B.

- There are approximately 420,000 Ohioans 80 years and older. As of now, Ohio expects to receive around 100,000 vaccines next week for this age group, so it will take some time to vaccinate this group.
- Gov. DeWine: Local health departments, emergency management agencies and provides in each county will notify the media tomorrow and Thursday about the process residents can used to be vaccinated in their counties: times, locations, etc.
- On Thursday, Jan. 16, ODH will post info on what providers are being allocated in vaccinations for next week. Residents will be able to search by zip code and by county. Info will post on the coronavirus website.
- In the coming week, as more vaccines become available and Phase 1B opens up to more Ohioans, more providers will be added.
- Ohio anticipates vaccinations will be available to those 75 years and older by Jan. 25. The following week, vaccinations will be available to those 70 and older. And on Feb. 8, anticipate vaccines will be available to Ohioans 65 years and older.
- Also during the week of January 25, vaccinations will be available to those with severe congenital, developmental or early-onset medical disorders.
- Today, Gov. DeWine signed an order authorizing 580 Ohio National Guardsmen into state active duty to assist during the presidential inauguration in Washington, DC. This group will also assist in Ohio.
- Lt. Gov. Husted announced that 12 workforce partnerships have been awarded \$2.5 million through the Industry Sector Partnership Grant.


