Executive Summary

In the last 24 hours, the Ohio Department of Health reported 7,654 (807,293) total new cases, 37 (6,289) ICU admissions, 109 (9,990) deaths, and 340 (42,491) hospitalizations.

The State EOC is currently at Partial Activation as it continues to coordinate response to COVID-19. While the EOC is available for use by all Emergency Support Functions, ESFs 1, 5, 6, 7, 8, 11, 13, 14, and 15 will remain activated for the ongoing response.

 - This ordering process is in addition to the current state allocation process and is NOT replacing the now bi-weekly state allocation process; this should only be used for sites that need product in between allocation cycles.
 - The State of Ohio/ODH has filled six (6) hospital requests for 41 ventilator kits total.
 - There are no pending requests for ventilator kits.
 - There are 855 State owned ventilator kits available

 - Ohio COVID-19 numbers for January 14: ODH reports 7,654 new COVID cases. Total cases: 807,293. There were 109 COVID-related deaths reported. Total number of COVID-related deaths: 9,990 (10 away from 10,000 deaths). ODH also reports 340 new hospitalizations, including 37 new ICU patients.
 - Gov. DeWine and Lt. Gov. Husted held a COVID-19 Update press briefing today:
 - Gov. DeWine noted: As of Jan 14, Ohio has given 361,603 COVID vaccines. The state is looking for its allotment to increase in the near future. Right now, the

vaccine is scarce. Ohio's goal is to eventually vaccinate anyone in the state who wants a vaccination. "We must take this one week at a time."

- Tomorrow (Jan 15) ODH will launch the COVID-19 vaccine portal on the coronavirus website to help citizens find a provider that has been allotted vaccines. Info can be found by entering either the zip code or county.
- The Ohio Public Health Advisory System map for this week continues to show every county has high incidence of COVID-19. Ohio is not showing a dramatic surge in cases after Christmas and New Year, but there is a bit of an upswing. Hamilton County is at Purple, Level 4.
 - Clermont and Lorain counties are on the Watch List, nearing Level 4.
 - Gallia, Hocking, Monroe, and Vinton counties are Orange, Level 2.
 - All other 85 Ohio counties are Red, Level 3.
 - At the statewide level, new COVID cases per capita have increased since last week. Ohio is now close to 740 cases per capita; last week the state was at 657. Incidence: COVID-19 cases per 100,000 residents.


