### Executive Summary

In the last 24 hours, the Ohio Department of Health reported 2,026 (943,291) total new cases, 10 (6,949) ICU admissions, 59 (16,453) deaths, and 104 (48,739) hospitalizations.

The State EOC is currently at Partial Activation as it continues to coordinate response to COVID-19.

While the EOC is available for use by all Emergency Support Functions, ESFs 1, 5, 6, 7, 8, 11, 13, 14, and 15 will remain activated for the ongoing response.

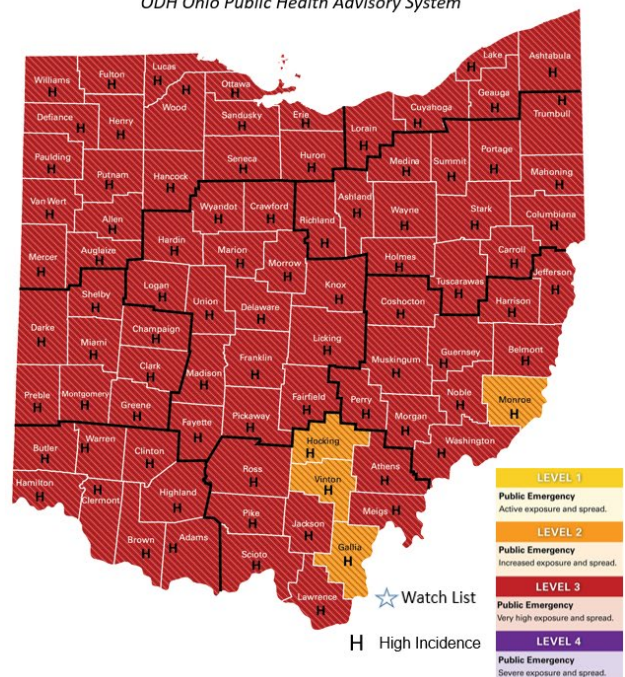

## State Community Lifeline Status

In-state Response | Ongoing External Support | Assistance Needed

### Primary Lifeline



- ODH reports a continued decline in key metrics since late December
- Three active RRF remain in progress; 14 addressed and are no longer active
  - OHNG Title 32 support has been extended into September, 2021.
  - Eight million nitrile gloves have been requested
  - Battelle CCDS funding is approved through February 28, 2021
  - Mass Vaccination Resource Requests (5) have been submitted to FEMA.
- Medical Care:
  - Emergency Department visits are on the decline since late December
  - Title 32 OHNG personnel are supplementing Long-Term Care facility staffing as needed
- Public Health:
  - Ohio is working through phase 1b of its [Vaccination Program](#)
  - Title 32 OHNG personnel are supporting sample collection and ODH labs
- Medical Supply Chain: Title 32 OHNG personnel are supporting the RSS and Adelaide Warehouses
- Fatality Management: ODH assets are deployed and pre-staged to support County EMA needs



- Food: Title 32 OHNG personnel are providing support to Ohio-based food banks
- Shelter: Non-congregate sheltering planning and response continues
  - [\(Potential quarantine locations\)](#) have been identified
  - Homelessness workgroup continues to collaborate on response



- Law Enforcement/Safety:
  - ODRC staff and incarcerated population cases are still occurring, but have stabilized
  - State Active Duty OHNG members are providing staffing support to select ODRC facilities
  - ESF-13 is providing site security at select ODH locations

## FEMA Community Lifeline Component Updates

Updates are provided by Emergency Support Functions for the reporting period.

### Public Health (Primary Lifeline)

- Medical Care (ESF-8):
  - In Zone 1 there were 92 COVID + admissions the last 24 hours (down 50% from the 179 admissions on 2 February).
    - The zone is reporting 70% utilization for adult Med Surge and 68% for adult ICU beds.
    - 26 hospitals reporting strained staffing for nurses.
  - In Zone 2, there were 69 COVID positive + admissions in the last 24 hours.
    - The zone is reporting 72% utilization for adult Med Surge and 71% for adult ICU beds.
    - The numbers are lower for pediatrics with 45% med surge and 64% ICU utilization.
    - 15 hospitals (40% of the total across the zone) reporting strained staffing for nurses.
  - In Zone 3 there were 38 COVID+ admissions the last 24 hours (down 33% from the 57 admissions seen on 2 February).
    - Currently the zone is reporting 69% utilization for adult Med Surge and 74% for adult ICU beds.
    - The numbers are lower for pediatrics with 45% med surge and 68% ICU utilization.
    - 16 hospitals reporting strained staffing for nurses.

- Health Care Supply Chain (ESF-7, ESF-8):
  - The Therapeutics allocation survey link sent to hospital points of contact statewide to determine who would like to be considered for this cycle (February 18th – March 3rd) .
  - Results need to be submitted by Wednesday @ noon in order to calculate facility level allocations.
  - There is currently a surplus of monoclonal antibodies in hospitals across the state according to the data that is reported to the Ohio Hospital Association every Wednesday.
  - As of 10 Feb 21 there were 8,490 doses of the Regeneron antibody cocktail and 16,243 doses of the Eli Lilly drug on hand.

*Actions Taken:*

- The Agriculture Work Group met with food supply chain stakeholders yesterday, February 16.
- The pork industry discussed concerns with changes to OSHA protocols in large meat packing plants as a result of the Administration change that has the potential to slow down meat processing in Ohio.
- Also, the Farm Bureau is advocating for early guidance for the safe operations of the state and county fairs.
- Finally, AGR, ODH and JFS are preparing a rebranded toolkit for migrant and seasonal farmworkers and growers for the upcoming season.

*Planned Actions:*

- The pork industry small working group is scheduled to meet February 17 for additional updates on COVID impacts.

- ODRC has 150 incarcerated adults COVID-19 active positives and 130 deaths Ohio National Guard, 70 soldiers activated for security missions at Corrections Reception Center, Franklin Medical Center, and Lorain Correctional Institution, 22 soldiers activated at 6 institutions to assist with symptom screening missions.

### 15 | Public Information

- Joint Information Center

*Actions Taken:*

- Pop-Up Testing today in Cincinnati; Pop-up testing on Thursday in Burlington, OH (Lawrence Co).
- This week, COVID-19 vaccinations are available to Ohioans with certain high-risk medical conditions, defined in Phase 1B of the Ohio Vaccination Program.



- The vaccine is also available to Ohioans age 65 years and older, and to schools in 27 counties listed in week #3 of the vaccine distribution list.
- Gov. DeWine and Lt. Gov. Husted held a COVID-19 Update press briefing today.
  - Gov. DeWine: Due to severe winter weather across Ohio and across the country, delivery of the Pfizer and Moderna vaccines may be delayed a day or two. Smaller shipments from the RSS warehouse are running on a two-hour delay.
  - Some vaccine providers have canceled appointments due to snow emergencies, but many are continuing to vaccinate. To Ohioans who have not heard from their providers and who want to confirm their scheduled appointments, contact your provider or visit your provider's website.
  - Ohio Central (Statewide) Scheduling System Update – The first phase for launching the system is complete. The portal is expected to go online on Sunday, Feb.21. Ohioans interested in getting a vaccination will be able to put in their zip codes and pull up available appointments within 20 miles of their residency.
  - Ohio partners, including the Area Agencies on Aging will be available to help individuals who do not have internet access, navigate appointment scheduling.
  - Ohio COVID-19 numbers for February 16: ODH reports 2,026 new COVID cases. Total cases: 943,291. There were 59 COVID-related deaths reported. Total number of COVID-related deaths: 16,453. ODH also reports 104 new hospitalizations, including 10 new ICU patients. Ohio COVID-19 hospitalizations for February 16: 1,566.

- 331 ONG personnel work in 14 food banks around the State of Ohio.
- 2 specialists support the ODH Labs.
- 110 medical professionals are part of the sample collection teams.

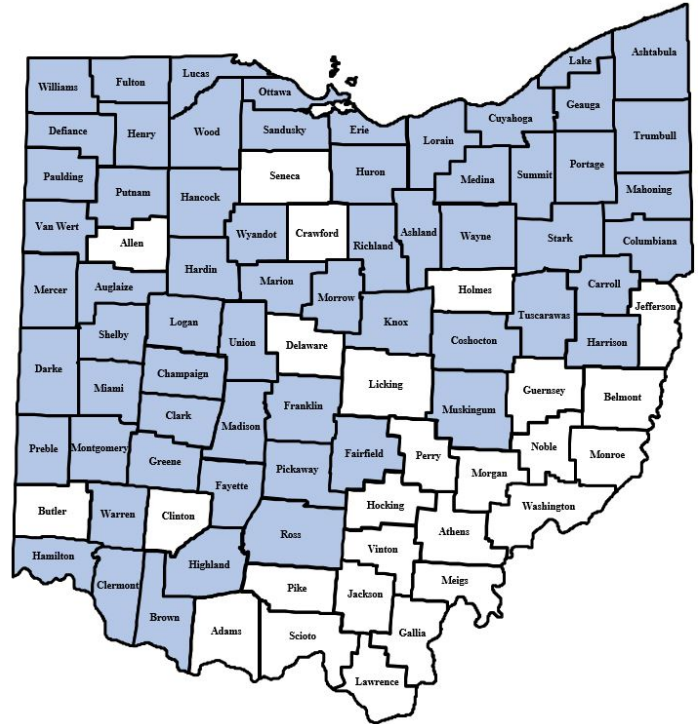

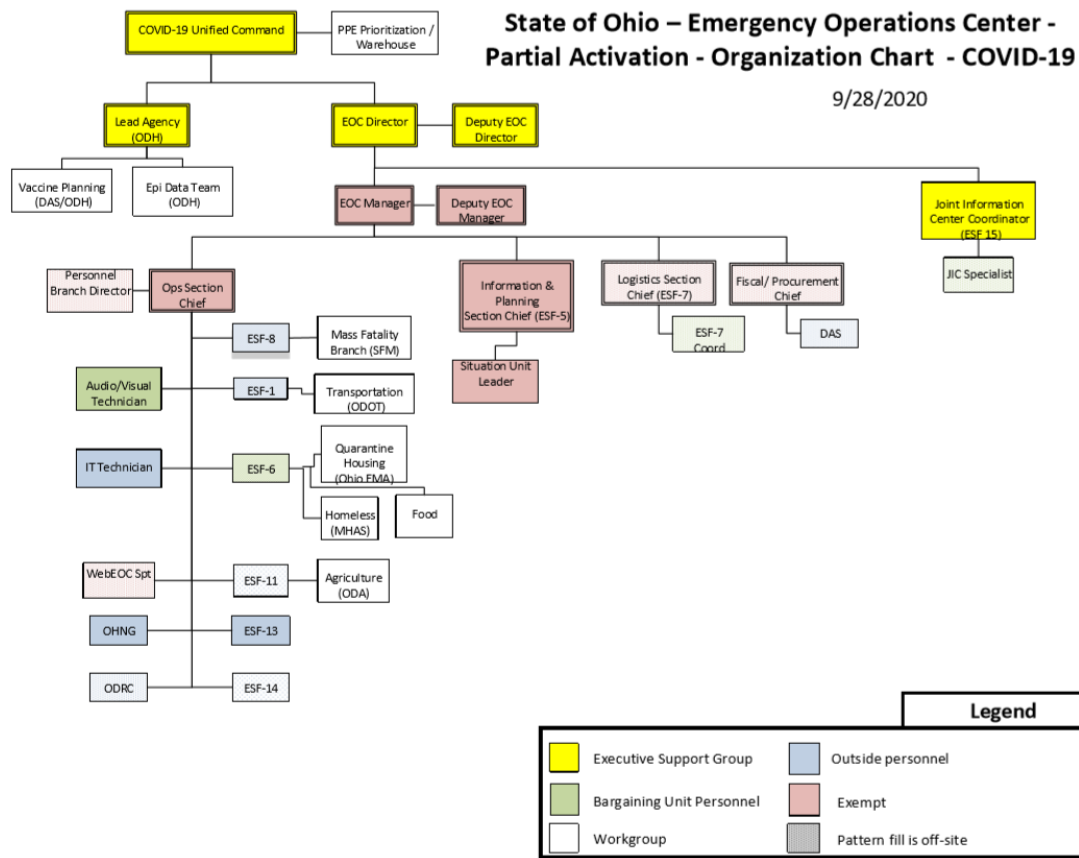
