Executive Summary

In the last 24 hours, the Ohio Department of Health reported 1,883 (992,223) total new cases, 10 (7,287) ICU admissions, and 114 (51,756) hospitalizations.

The State EOC is currently at Partial Activation as it continues to coordinate response to COVID-19. While the EOC is available for use by all Emergency Support Functions, ESFs 1, 5, 6, 7, 8, 11, 13, 14, and 15 will remain activated for the ongoing response.



State Community Lifeline Status

In-state Response | Ongoing External Support | Assistance Needed

- ODH reports a continued decline in key metrics since late December
- Six active RRF remain in progress; five RRF are submitted; 14 RRF addressed- no longer active
 - OHNG Title 32 support has been extended into September, 2021
 - FEMA support to mobile vaccination capabilities
 - Federal support of Type 1 Community Vaccination Clinic in Cleveland to include outreach & communications
 - Eight million nitrile gloves have been requested
 - Battelle CCDS funding is approved through March 20, 2021
 - Mass Vaccination Resource Requests have been submitted to FEMA
- Medical Care:
 - Emergency Department visits are on the decline since late December
 - Title 32 OHNG personnel are supplementing Long-Term Care facility staffing as needed
- Public Health:
 - Ohio continues to move through its Vaccination Program

- Medical Supply Chain: Title 32 OHNG personnel are supporting the RSS and Adelaide Warehouses

 - This is a 6% decrease in COVID positive patient counts in the last 7 days.
 - There were 112 COVID positive admissions over the last 24 hours across the state.
 - COVID positive admissions have decreased 28% in the last 7 days.
 - Overall resource utilization remains stable.
 - Currently the state is reporting 73% utilization for adult Med Surge and 69% for adult ICU beds.
 - Pediatrics Med Surge utilization is at 46% and ICU bed utilization is at 67%.
 - Ventilator usage is at 29% statewide for COVID and non-COVID patients.
 - Approximately 12% of the ventilators that are currently in use, are by COVID positive patients.

- o ODRC continues to gradually improve for both staff and inmate positives.
- County jails are continuing to improve.
- o 90% of inmate positives are in their reception facilities.
- 10,000 J&J shots have been administered in the last 10 days. Still need more vaccine to complete corrections staff.
- Lorain Correctional continues having staffing difficulty, but ODRC is figuring it out internally.

- o On March 16:
 - Governor and Mrs. DeWine visited the Shelby Community and Senior Center on March 16, where approximately 100 people were vaccinated.
 - Governor DeWine and representatives from FEMA, City of Cleveland, Cuyahoga County, and Cleveland State University (CSU) welcomed the general public who came for their vaccinations at CSU's Wolstein Center. Gov. DeWine held a press conference at the Wolstein Center:
 - Gov. DeWine announced expanded vaccine eligibility in Ohio beginning on Friday, March 19 for Phases 1E and 2C of Ohio's Vaccination Program.
 - Phase 1E includes Ohioans with cancer, chronic kidney disease, chronic obstructive pulmonary disease, heart disease, and obesity.

- Phase 2C extends eligibility to Ohioans who are 40 years and older.
- Starting Thursday, March 18, pop-up mass vaccination clinics will open in Cincinnati and in Columbus. Fifteen long-term mass vaccination clinics will open regionally across Ohio in the coming weeks.
- Beginning on Monday, March 29, eligibility will be expanded to all Ohioans age 16 years and older. FDA authorizes only the Pfizer vaccine for youth age 16 and 17 years old.




State EOC Organization Chart (COVID-19-specific)
