The region continues to have opiate related problems. There is a meeting on 9/28/16 for those wishing to be a part of addressing the issue.

There is a con-ed program concerning opiates being developed that will be hosted on the Council web site.

A new ad hoc committee has been created to address fire and EMS safety with regard to acts of violence. An invitation went out on the list serve.

Kettering Health Network's Surgical Emergency Response Team (SERT) discussions are ongoing with the goal of being up and running in November.

There were two complaints received regarding persons that may not be eligible to access the drug bags. These items were pursued and resolved.

Committee Reports:

A. Administration

Budget & Finance: No report.

He referenced the fan growth and popularity of the Council Facebook page, working with the PR committee, and working on bringing in organic education. Legislative & Advocacy Committee: MOLST bill passed the Ohio House and is in Senate. It is expected to pass. Legislation regarding drug bag system is on the House floor. The committee has meetings set up with local reps. There is a handout attached concerning Ohio Bill 1113 - CPR in Schools.

Grants Committee: No report.

B. Medical:

Drug Bag Exchange:

Bags are being damaged, please handle with care. It will take time to replace the 900 plus bags we have in the system.

The Board of Pharmacy is very actively inspecting in the region. The have been looking at O2 logs. Brendan will send out an example of a log the BoP likes.

Put the blue seals in the pouch on which they were located whenever exchanging a bag.

There have been more broken Narcan vials.

Quality Assurance: Chris Kyer is stepping down as Chair and Meredith Lawhorn has agreed to be the new chair.

Standing Orders: RPAB signed off on the protocol. Jack needs proofreaders for the new protocol.

Infection Control: GDAHA members have signed off on the protocol which will be added to the SOs and the protocol will be posted on the web site.

C. Pre-Hospital Care:

Education Committee: Waiting for the final version of the protocol and will then work on new questions for the test bank. There was discussion at the meeting regarding adding new types of questions for the test.

Research: Setting up goals for next year.

Pediatric: Report provided in New Business.

Organization Reports:

MC Fire Chiefs Association: Discussed MARCS, new SOs and team members are needed for Region 3 Rescue Strike Team (R3RST) and OH-TF1 (USAR).

Miami Valley Fire/ EMS Alliance: Fit testing and assessment testing has been completed. Webinars will resume in the new year. Annual audits are being prepared. Next meeting is Oct 19 @ Sinclair.

State Board of Emergency Medical, Fire and Transportation Services (EMFTS): EMSIRS 3 is on the way. Be ready.

RPAB, **Division 3**: The group has signed off on the 2017 protocol. Next meeting is 10/13.

SORTS: Has received data and can now resume meetings.

GDAHA: No report.

Metropolitan Medical Response System (MMRS):

- RTF Train the trainer coming.
- There are 8 new RTF caches being placed in the region.
- There is a local group following Fire and EMS crews in Dayton. If this happens in your community, call the PD immediately; it is not effective to do follow up after the fact.
- One of the largest drills in the state is being planned for 5 May 17. This will be a mass fatality drill.

Old Business:

Veterinary Standing Orders – Mark Senseman reported that the Ohio Veterinary Medical Association met with the veterinarians at OSU and discussed potential new guidelines pertinent to the new law. It was reported that the information will be added to the Council website and we are still working on an official statement about the law. David thanked Mark for his work on the topic. Jeremy Lane reported that the legislation doesn't provide guidelines about what you can and can't do, it just states that you are criminally and civilly ok if you do what is covered in the law. The law will not become part of the protocols this year but individual departments are able to follow it if they would like to. Departments will still need to have their Medical Director sign off on this if they choose to. The group was reminded that agencies will need to purchase their own narcan because it is not permitted to use narcan from the GMVEMSC drug bags for animals.

New Business:

- Dayton Veterans Administration Medical Center Overview a representative of the Dayton VA discussed the need for a better relationship between EMS and the nursing and ED staff. She provided an overview of their capabilities and discussed a potential survey that will be sent out to squads regarding improvement suggestions.
- "OD MCIs" David discussed the potential for mass casualty incidences of drug overdoses in our area. He provided information regarding an overdose cluster coordination group that is made of multiple agencies and reviewed what is stated in the current draft of the plan. David noted that he hopes the plan will be operational within the next month. Anyone interested in participating should email David. Public Health will help with the messaging template.
- **Ohio First Net** representative gave an update on plans for the planned nationwide and statewide broadband communications system for first responder agencies.
- **Pediatric Emergency Care Coordinators** Heather Koss discussed information that was sent out on the listserv regarding requirements related to Pediatric Emergency Care Coordinators. At David's request, Heather is researching whether each agency will need to have their own or if it would be possible for Council could have one that would be used by all member agencies.
