GROW Team is collaborated with Dayton Police Department -2018 to present
 - a. Respond to overdoses
 - b. Assist with getting souls into treatment facilities within 24-48hrs.
 - c. Not limited to Montgomery County residents

3. Aaron Vance, Monroe Fire, FF/Community Paramedic
Paramedicine program collaborated with Atrium Medical Center- 2015 to present
 - a. model based on CHF, COPD, Heart Attacks, Strokes, Asthma, Diabetes and Falls
 - b. can refer to Senior Services throughout Butler and Warren counties

4. Paula Balcom, Riverside Fire, FF/Community Paramedic
Paramedicine program began in 2017 after being approached by EPA and CareSource grant in partnership with Reachout Montgomery County.
 - a. Model based on Respiratory
 - b. Partnered with a Nurse
 - c. 2019 model began to focus on fall prevention/lift assist

Non-profit organization in Montgomery County closed due to covid19.
 - a. Telemedicine version open 12/21
 - b. Patient accepted by referrals only
 - c. Clinic scheduled to open first quarter 2022
 - d. Pharmacy scheduled to open 2023

Alternate transportation topic continued from July 2021 meeting.
 - a. crisis stabilization unit open in September 2019
 - b. Residential facility currently open
 - c. Currently no alternate EMS transport protocol put in place at this time
