1. Tracy Clare, Planning and Training Specialist for PHDMC  
Mobile Vaccinations (MVT's) that includes 5 or more individuals
  - a. Provides in-home vaccinations collaborated with surrounding Fire Departments
  - b. Provides the vaccine, diluent, supplies and vaccination cards
  - c. Provides in-home scheduling for second dose
  - d. Provide vaccinations for single patients through their Homebound program
  
2. Chris Heaton, Beavercreek Fire, FF/Paramedic  
Paramedicine Program began in January of 2021
  - a. Program targeted initially targeted Extended Care Facilities
  - b. Moved to Fall reductions in Elderly and Community Based Program
  - c. Provides Home safety assessments
  - d. Provides smoke and CO detectors
  - e. Advised by Children's Medical Center of trach patients, feeding tubes etc.
  - f. Program goal is to reduce Re-admissions and EMS/ER encounters
  
3. MAB infusions  
Recognizing need from MVH infusion centers to provide MAB's to patients who reside in Speciality Care Centers.
  - a. Miami Valley Hospital is the regional hub for MAB distribution
  - b. Contact EMS Coordinator, Laura Clark to schedule distribution
  - c. In the State of Ohio, on or about November of 2021, the first administration of Monoclonal Antibodies was successfully completed outside of the hospital setting
  
4. MedStar Handout Discussion  
Partial review of MedStar Mobile Handouts on sustainable funding for Community Paramedicine Program
  
5. Zoom meeting vs meeting In-person  
Topic for discussion was about going back to in-person dialogue
  - a. President Marker stated we will remain via Zoom for now due to rise in Covid19 cases
